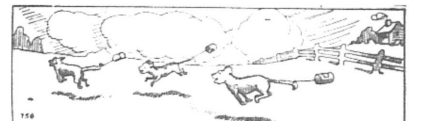

**GEORGE.**

War is not supposed to develop the latent sense of humor in a commanding general, but Washington's wit never forsook him. His successful stratagems were little more than practical jokes raised to the highest power. They always "worked," and then he waited laughing in his military sleeve while his fatwitted enemies tried to play his own tricks back on him. Even in his retreats Washington perpetrated the great Jersey joke still perpetuated by so many millions. He told an English traveler named Weld that he had never so much enjoyed by mosquitoes, for they used to bite through the thickest boots.

When the war was over the victorious commander entertained the vanquished general, Lord Cornwallis, with some of the leaders among the French allies. Washington predated, in calling for toasts, Cornwallis, with an obliviousness of the changed conditions that was truly English in its nature. "The King of England" as a subject for high praise.

The other guests were in consternation. Who the presiding genius, on whose very head King George had set a price, present this as an insult?

"The King of England," announced the toastmaster general, raising his glass. The guests gazed at him, transfixed with astonishment.

In attempting to make their hero appear to have been stern, those pedantic biographers related not what George Washington really did, but what they imagined such a boy or man ought to have done under given conditions.

Washington would have laughed heartily at Weems' hatch-and-cherry-free story if he had ever heard it—which he never did, for it was not invented till a later edition of the erring writer's Juvenile history, six years after Washington's death. Yet the real hero of the cherry-free fiction would have found it the occasion of gravity as well as mirth. In the stilted story of "Little George and His Pa," Weems was only carrying out the idea of his pa, to tell not what the small boy actually did, but what the conventional little prig he conceived little George Washington to have been would have done if he had cut down his father's favorite cherry tree.

At the age of twenty George was the chosen envoy to carry a "notice to quit" from the governor of Virginia to the French commander on the Ohio region. He wrote in his journal of that expedition concerning the supper given him by the French and Indians at the fort at Venango.

A complete roster of Ohio troops that served in the war with Spain has been completed by the state adjutant general's department. It gives the name and history of every man who served in the Ohio volunteers. It comprises a list of more than 10,000 names. Similar volumes have been compiled of Ohio veterans of the Mexican and Civil wars.

Next Saturday five fourth class postmasters of Huron county, working for Uncle Sam at North Starfield, Collins, Havana, Boughtonville and West Clarksville, will take a civil service examination in Norwalk to protect their jobs. An order was issued on Dec. 24, last, by the federal civil service commission requires that all fourth-class postmasters, previously appointed, must pass a passing grade over a prescribed list of questions if they desire to continue as custodians of the mails.

A new method to dodge taxes has been discovered. Attorney General Hogan Monday gave an opinion to the state tax commission that if a man owns non-taxable bonds they may not be taxed on him even if they are past due and still unrepaid for redemption. An owner of non-taxable bonds may hold them until after the listing period is past and present them for payment then, but escape returning the money which he receives for them.

Return to Old Schedule.

A new schedule will be put into effect on the S. N. & M electric line Monday, Feb. 16, at which time through service between this city and Mansfield, over the line of the Mansfield Light & Power Co. will be discontinued. An order was issued to return to the old two hour schedule between Norwalk and Shelby.

Under the new schedule the first car will arrive at this city at 11 o'clock leaving immediately on its south trip. The second car will leave at 8:10 and the next car at 9:45 o'clock. From this time on cars will leave Norwalk for Shelby every two hours, or at 45 minutes after the odd hour until 9:45 p. m. At 11:10 o'clock a car will leave this city running as far as Fairfield.

The incoming cars will arrive in Norwalk at 15 minutes after the odd hours, laying over here for thirty minutes. At Shelby direct connections will be made for Mansfield, Norwalk Experiment.

Stopping Losses From Rats and Mice.

Rats and mice cause an enormous loss in crops where corn is stored over winter. It is difficult to keep them from entering the crib. Often an apparent rat-proof storage house becomes infested and no traces can be found of how the rodents gained entrance. Various methods are used to prevent entrance into the crib. An all-metal crib in a concrete foundation is an effective method of keeping the rodents from the grain. This sort of a crib is expensive, however. Another plan is to elevate the crib on posts some distance above the ground, wrapping tin or sheet metal about the posts. If properly done this method is usually effective. Another means that may be resorted to is to use, instead of posts, the elevated crib rested on ordinary sewer pipes. If we use the concrete foundation with the flange end down. The inside of the pipe is refilled with iron rods or bars that may be found about the farm premises. If a good, solid foundation, almost any weight of crib and contents may be carried with safety and rats and mice may be kept away effectively.

Lower the cost of living by improving the country roads, thereby giving the farmer easy access to the markets, which will encourage them to produce more. Heavier production means lower prices.  
 That's the theory of James R. Marker, state highway commissioner, who claims to give Ohio the best roads in the United States. Marker will have at his personal disposal this year \$800,000 and every year thereafter for ten years there will be \$3,500,000 at the disposal of the state highway commissioner for use on roads in the state.

The Lewisich Co. of Akron telephoned last week for three young women to fill office positions and stated they would need many others in the near future. Other calls are from Galion, Ashland, Cleveland, Vermillion, all preferring O. B. C. trained students. One call comes from Oklahoma offering \$250.00 to the first to start. Several students left school last week to accept positions, even before fully completing the course. Those who undergo the training offered at Oberlin are certain of positions.


**Return to Old Schedule.**

A new schedule will be put into effect on the S. N. & M electric line Monday, Feb. 16, at which time through service between this city and Mansfield, over the line of the Mansfield Light & Power Co. will be discontinued, and the S. N. & M. will return to the old two hour schedule between Newark and Shelby.  
 Under the new schedule the first car will arrive in this city at 6:40 o'clock leaving immediately on the return trip to Mansfield at 8:10 and the next car at 9:45 o'clock. From that time on cars will leave Newark for Shelby every two hours at the rate of one car per hour until 9:45 p. m. At 11:10 o'clock a car will leave this city running as far as Fairbairn.  
 The morning cars will arrive in Newark at 15 minutes after the odd hours, laying over here for thirty minutes. At Shelby direct connections will be made for Mansfield - Newark Experiment.

**Stopping Losses From Rats and Mice.**

Rats and mice cause an enormous loss in cribs where corn is stored over winter. It is difficult to keep them from entering the crib. Often an apparent rat proof storage house becomes infested and no traces can be found of how the rodents gained entrance into the crib.  
 An all-metal crib on a concrete foundation is an effective means of keeping the rodent out of the grain. This sort of crib is expensive, however. Another plan is to elevate the crib on posts some distance above the ground, wrapping the posts with the elevated crib rested on ordinary sewer pipe. These are set on the concrete foundation with the flange end down. This method is not so effective as the all-metal crib. If the elevated crib is made of concrete which is re-inforced with iron rods or bars that may be found about the farm premises. If large amounts of grain are stored in cribs a good, solid foundation, almost any weight of crib and contents may be carried with safety and rats and mice may be kept away effectively.

**STRIKE STIRRED NEAR THE CLOSE**

**DEBATE ON MILLS BILL IS MARKED BY BITTER PERSONALITIES.**

**PASSED BY NARROW MARGIN**

**Kramer Amendment Is Cut Out By The Senate—Charge That Administration Was Pledged to Publishing Companies Causes Uproar in the House—School Relief Program Completed.**

(By Denny Dunovan.)

Columbus, O.—One of the most stirring incidents of the session came close to the finish in the contest over the Mills utility bill. Following a stormy debate, bristling with virulent personal attacks and charges of bossism and lawbreaking, the bill was passed in the senate 17 to 15, after it had been stripped of the Kramer amendment, requiring bonds issued by municipalities for the purpose of purchasing utilities to be based upon the concern and not the general credit.

Simultaneously there was an uproar in the house caused by the charge of Representative Woodworth that the administration had pledged the school book publishing companies that no legislation affecting their interests should be passed. Before the disorder had subsided the senate passed precisely that kind of a measure, the Hudson bill, creating a state uniform text book commission, mandatory in rural and village schools. This completed the general schools relief program of the session.

**Back to the People.**

The bill fixing the gross amount of coal produced by a miner as the basis for the wage scale paid is now a law and marks the close of a legislative contest between workers and mine-owners which has lasted for more than 30 years. After a conference representatives of the Coal Operators' association announced that the Green coal screen bill would be taken to the people of the state through the referendum. The committee was appointed to begin the work of arranging for the circulation of petitions and the general organization of the fight. **"Blue Sky" Law Amendments.**

Several drastic features of the "Blue Sky" law are modified in amendments designed to make it absolutely safe from attack in the courts and to lighten some of the restrictions which have been found to be an unnecessary hardship on legitimate brokerage business. A requirement eliminated is the filing of advertisements and circulars. Another change made allows the commissioner to issue a temporary permit pending the hearing of an application and denies the commission the right to appeal when a court reverses his ruling in refusing a license.

**Bill Aimed at Loan Sharks.**

Interest rates for small loans are limited to 2 per cent a month, with permission to charge over 25 per cent for pral or examination of the borrower, by the terms of a bill by Senator Lloyd. The measure is aimed at small loan agents who now lend at interest ranging as high as 120 per cent yearly, and escape the present law regulating their rate of interest by taking no security.

**For Compensation Fund.**

State Auditor A. V. Dostabey set off to the credit of the state insurance fund under the Green workmen's compulsory competition act the state's share of the premium necessary to protect the public employees who come under its provisions. It is estimated the state will contribute about \$25,000 although the amount cannot be determined until all state pay rolls are gone over.

**Compensation Act Change.**

Further danger to Ohio employees through judicial interpretation of term "willful act" in the workmen's compensation law is eliminated by an amendment which reads "Willful act as employed in this section shall be construed to mean an intentional act done with purpose and design of inflicting the ensuing injury."

**Limiting Justices' Authority.**

Governor Cox recommends curtailment of authority of country justices of the peace. Under present laws a person may be compelled to travel from a city by the country to be tried before a justice of the peace. The measure which the governor advocates restricts justices to hearing cases only in their immediate vicinity.

**Farming To Be Taught.**

The House passed the Cabbill bill providing for the teaching of agriculture in all rural schools, by a vote of 39 to 37 with an additional offering by Representative Heighard, requiring teachers of agriculture to possess the same qualifications as the county assistants and school teachers.

**CAPITOL CHAT**

**Victory For Dry Forces.**

By defeating the bill introduced by Representative Bour, which provided for the appointment of a special commission of five members by the governor to investigate financial conditions of municipalities of Ohio and report to the legislature in 1916, the dry forces are considered to have won a victory in the lower house of the legislature. The bill provided an appropriation of \$1,000 for the expenses of the committee. The preamble of the bill set forth that "some cities of the state are in financial straits because of the loss of revenues due to the operation of the liquor license law," and the committee was empowered to summon witnesses and procure testimony with a view to making recommendations to the governor on present financial conditions of cities and municipalities.

**School and Civic Bills.**

The Lowry bill, creating county boards of education, with county superintendents and district superintendents and the keystone of the arch of the new rural-school system was passed by the senate. What is regarded as the very last word in the program of social uplift was spoken when the house of representatives confirmed the prohibition statute. The bill provides for opening of all public buildings supported by taxation, and all school-houses and schools, and is in the use of any "respectable organization" applying therefor in order that the people, youthful and adult, may be entertained and educated.

**Waiver of Claim Urged.**

In addition to recommendations that had been made known beforehand, in a committee report to survey the need of surrendering a larger portion of the state tax to municipalities, Governor Cox asked that the state waive its claim to \$42,000 interest upon the funds deposited in the depository Columbus Savings and Trust company, in order not to cause the depositors greater loss.

**Rolling an Embarrassment.**

Lawyers declare that the decision of the supreme court in the Baxter case will result in a loss of money and applied in Ohio for half a century, and almost a complete overturn of the law is now being attempted.

**The People's Telephone Company, of Geneva, and the Austrian Telephone company, of Austintown, both in Ashland county, want to build a toll line between Geneva and Austintown. A joint petition with the utilities commission was filed for this purpose.**

**Opposition manifested itself in the printing of 10,000 copies of the report of the Ohio school survey on the ground, stated by Senator Moore, of being that the survey is a waste of money, but the same is being done by other states.**

**Secretary H. F. Gayman, of the state agricultural commission, profited by reason of a ruling, given by Attorney General T. S. Hogan, to State Treasurer John P. Breaugh. The secretary may withdraw a \$10,000 bond, which he has given because it is not necessary, the attorney general holds.**

**The latest schedule of automobile license fees agreed upon is \$5 for all machines up to and including those of 20-horse power, from \$6 to 50-horse power including \$9, \$12 to be \$7, and for all machines of more than 50-horse power the fee is to be \$9. The fees, under which a law before the supreme court was from \$6 to \$12.**

**Upon the plea that with a greater tax duplicate there can be reductions in the use of money in various taxing districts, the state tax commission has asked assistance of all taxpayers in its effort to get full returns. Its efforts are directed particularly toward getting the returns of persons who property that does not fall beneath the direct gaze of the deputy assessor.**
