

Drunken Driver Crashes Pole; Cuts Power Off in Plymouth

Estel Carey of Shelby, narrowly escaped death Saturday afternoon when his car left the road and struck a high tension pole near Vernon Junction and Shelby, throwing a section of the power lines out of commission, which cut off electric current in Plymouth and vicinity for more than five hours.

Damage is estimated at \$1,000 to power lines.

Shelby police were on the trail of Carey after he allegedly sidwiped a parked car owned by Clayton Baldrige, arrived shortly after the accident. Carey, who police said was intoxicated, lost control of his car and ran off the road 200 feet before striking the high tension pole.

Sparks from the shorted wires carrying 13,000 volts had started fires in the leaves and weeds surrounding the car when officers arrived. The Shelby fire department was called and power was cut off from the substation before Carey could be taken from the automobile.

It was first thought that Carey was dead, and Shelby police called county coroner, Dr. L. B. McCullough, and Deputy Sheriff Glenn Humphrey. Carey was removed from the car and taken to the Shelby hospital where he was treated for shock and released to the custody of officers.

Carey was arraigned in court and received a fine of \$200 and costs and sentenced to 60 days in the Richland county jail by Judge H. H. Schettler. His driver's permit was revoked for three years. Judge Schettler suspended \$100 of the fine on the condition that the same amount be paid half of the damage to his car, and suspended the jail sentence.

As a result of the shut-off Saturday afternoon the foundry at the Fate-Roth-Heath Co. plant "lost a heat" which amounted to several hundred dollars. Around 6:00 o'clock the water pressure in Plymouth became dangerously low. Through the efforts of Electrician C. R. Crawford, his assistant Ernie Rooks, and L. E. Brown the temporary plant here was put into action sufficiently to start the pumps at the water plant and maintain a pressure.

Local business men were in a predicament in the latter part of the afternoon, for as darkness came there were no lights.

The current went off in Plymouth and Shelby at 1:00 p. m., and after much work by repairmen, the power came on at 6:00.

Years ago Plymouth's substation or rather auxiliary unit, was sufficient to supply lights when the main source failed. However, under the present plan caused by the addition of numerous refrigerators, radios and other electrical appliances, the auxiliary unit is capable only of supply current in sufficient voltage to operate the water pumps.

RECEIVES LETTER

After receiving a message stating that her son, Lt. Eugene Philip was being held as a prisoner of war, Mrs. Edward Phillips received the following letter from the War Department:

"The cable from the International Red Cross reported your son to be a prisoner of the Italian government. Due to the indefinite status of the Italian government at this time, full information as to the present location of the American prisoners in their hands is not now available.

As soon as the Italian situation clears up and further information is received, you will be notified."

Funeral services will be held Friday afternoon at 2:30 p. m. in Newark.

Survivors include two daughters, four sisters and one brother. Her husband preceded her in death the past year.

Graduates

KEESLER FIELD, Biloxi, Miss. — A new role in Democracy's fight against the Axis today awaited Pfc. Elden W. Grammiller, son of Mr. and Mrs. Fred Grammiller, who was graduated as an airplane mechanic Tuesday from the B-24 Liberator bomber mechanic's school at this unit of the Army Air Forces Training Command.

Private Grammiller, with approximately 17 weeks of intensive training behind him, is now ready either for assignment to line duty wherever the big Liberators are operating, or to a flexible gunnery or factory school.

"On the line," it will be his duty, not to fly them, but to keep them in good flying condition so they will perform effectively. Before the big bombers take off he will make certain that the engines are running smoothly, that the electrical and fuel systems are functioning properly, that the landing gear is working correctly—that the plane is in perfect mechanical condition.

When the planes return he will help mend broken and twisted parts, change a damaged engine, patch up bullet holes and put the bombers back in service as good as new.

Army Air Forces experts long have recognized the importance of the ground crews who outnumber pilots 10 to 20 to 1, with the proven theory that a bomber is no better in action than its mechanics on the ground.

RELEASED FROM HOSPITAL

Boys Take Big Copper Kettle

Taking a copper kettle and sell it for junk brought much trouble to two local boys last week, the outcome of which is yet to be decided.

Last Wednesday, Oct. 13, Wm. Johns went out to his pasture on the Seaboard property west of Plymouth, and discovered that his 35 gallon copper kettle, which he used to water his cows, was missing. He reported the loss to Marshal Hulbert, who started an investigation, and which brought Earl West, 15, and Junior Reed, 16, into Mayor J. B. Derr's court Thursday evening.

At the hearing it was revealed that the boys had emptied the water out of the kettle, and took it to a junk dealer. The junk dealer, it is said, told the boys that he could not pay the price of old copper for the kettle, unless they took off the heavy iron band around the top. The boys proceeded to wreck the kettle, and then sold the old iron and copper to the dealer.

Under the state law the two boys had to be turned over to the juvenile court in Norwalk, as their ages were 15 and 16 years. The case of both boys was sent to Judge Luther Van Horn's court in Norwalk, who advised that Junior Reed be sent to Judge Cramer's court in Mansfield. Young West, it is said, pending guilty before Judge Van Horn, that he is being held, pending sentence. Young Reed, it is reported, entered a plea of not guilty, and he was released under bond, pending further hearing.

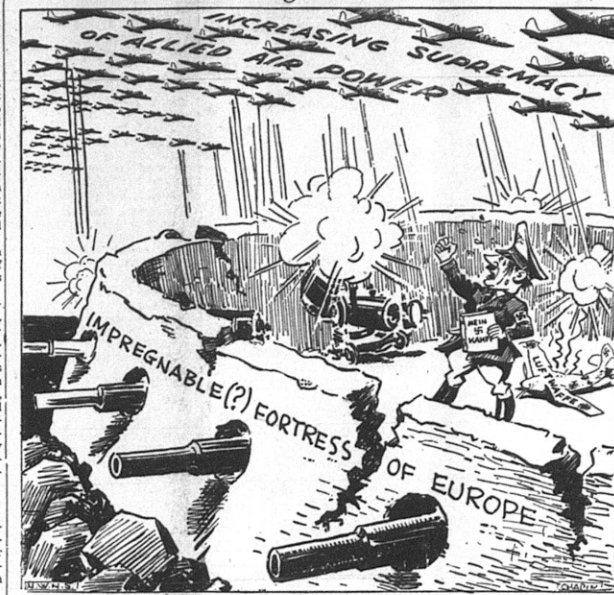
This is the first case of its kind in Plymouth for many months, and should be a warning to those youngsters who have a desire to destroy property under the cloak of "hallowe'ning."

The Man Who Neglected to Build a Roof



Cong. McGregor Reports His Findings of Interviews Here In Norwalk Nov. 1

LISTS WHAT HIS CONSTITUENTS THINKS AND WANTS; ASKS COOPERATION.

Representative J. Harry McGregor (Rep.) 17th District of Ohio, Monday, made the following speech on the floor of Congress, setting forth the desires of his people as he found them, as a result of his personal contacts with his constituents during the recent congressional recess.

Mr. Speaker, when Congress recessed I returned to my 17th Congressional district of Ohio to learn "what the folks back home are thinking about."

As had been arranged and publicized, I was at the court house of each county seat in my district for two days—interviewing anyone who cared to call—then each night I held an open forum, or round table discussion in the court room. After this tour, requiring twelve days, I again covered my district, making 18 speeches to various civic organizations and visiting with my constituents, in an effort to learn their opinions on the various issues confronting Congress and the country.

During the time spent at the court houses, I averaged 44 personal interviews a day. People came there to discuss problems of interest to them.

At the five open forum night meetings held in the court rooms the average attendance was 229. The average attendance at the 18 civic organization meetings (12 open forum meetings) was 237.

Therefore, Mr. Speaker, bringing contacted approximately 6,000 constituents, I believe I am in a position to report to Congress what the people of my district are thinking about and to offer to you and to the Congress their recommendations:

- My people:
1. Want to make every necessary sacrifice to win the war, but they are opposed to any unnecessary sacrifices.
 2. Want Congress to retain its rights and be a legislative body, and not let its control to any individual or group. They don't want a rubber stamp Congress.
 3. Want politics, jealousy, selfishness, greed and profligate taken out of our war program.
 4. Want to know the truth about our war production, war policy, our gains and losses on the battle fronts. They want the news to come from our government. They don't want to be dependent upon some of our Allies for this information.
 5. Want immediate dismissal of all on the Federal pay roll who are not needed, and who are not giving performance comparable

to their pay. Those not needed should be placed in armed service, on essential production lines or on the farms.

6. Want the Federal government to recognize State and local rights and the right of private and individual initiative.

7. Want Congress to form departments to be headed by individuals with practical experience—not theorists.

8. Want the right to work and the right to produce without unnecessary governmental red tape and interference.

9. Want Congress to establish a definite post-war policy, guaranteeing to the "boys and girls," when they return home, employment and a lasting peace.

Mr. Speaker, I am in complete accord with the above "Wants" of my people, and I believe them to be the desires of the majority of the people of our Nation. I therefore respectfully urge and request that the Leadership, as well as my colleagues in Congress, cooperate with me in every possible way in order that these wishes be fulfilled, all of which I am certain will be determining factors in bringing this War to an early and successful conclusion.

The famous "Bazooka" rocket gun will also be displayed. The troops will be carrying full field equipment, a rolling camp, a complement of WACS and several veterans from various theatres of the war. A medical detachment will also be with the caravan which will set up, with the local Red Cross, a first aid station.

The troops will arrive before noon and will feed noon "mess" in the open so that you may see what army food is like. The meal will be served from a rolling field kitchen. After "mess" the camp will be open for your inspection and troops will be there to demonstrate and explain this complete array of equipment. This is the first and perhaps the only time, that the citizens of Huron county will have such a privilege.

Parade And Patriotic Rally

A parade will be held in the early evening on the street of Norwalk. The massed bands of the Huron county high schools, the troops of the caravan, the Ohio State Guard, Veterans organizations, civilian defense corps, and other patriotic groups will participate. It should be the outstanding parade of many years. After the parade a patriotic rally will be held.

PLAYING SICK

The latest method the unions have thought up to call a strike without labeling it as a strike, is to have all members play sick.

By this subterfuge, and by having union leaders say that they had nothing to do with it, milk delivery men in New York and New Jersey thought they had found a smart way of getting around the anti-strike law.

This is just one of dozens of similar methods which have been tried, including slow-downs, sit-downs, and various excuses for absenteeism. In practically all cases union leaders declare the strikes to be "wildcat" affairs over which they have no control.

All are clear demonstrations of the fact that our anti-strike law is full of loopholes and is too weak to deal with the labor situation satisfactorily. They also demonstrate that the "no-strike" pledges of the parent union aren't worth the paper they are written on.

There is no doubt in most everybody's mind by now that the only way to prevent strikes is to give labor anything its leaders demand or to have a law which will deal out real punishment to all strikers. So far we have been settling strikes by the first method. It's time we did something about the second.

2,800,000 VEGETARIANS

Those of us who eat meat and can't get all we want of it, owe a debt of gratitude to approximately 2,800,000 people in this country who are confirmed vegetarians and don't eat meat at all.

If those people did eat meat, even under rationing, they would consume at least 5,600,000 pounds a week—so it is obvious that vegetarianism is doing a lot to keep a bad situation from being a lot worse.

The Institute of Public Opinion made probably the first survey ever made to determine the number of people who eat no fish, flesh or fowl and arrived at the figure above. The figure, of course, does not include babies who are too young to eat meat. But while we are expressing our thanks to the vegetarians we should also give a nod of acknowledgment to those infants who get meat ration points but confine their consumption to milk, juices and strained vegetables.

Unfortunately, the majority of vegetarians, according to the survey, hail from large cities. There probably isn't much hope that people who live in the country, and see juicy steaks and legs of lamb from the time they are running around on the hoof, can ever be persuaded that their appetites could be satisfied with a Sunday dinner featuring roast carrots.

Gas Company Asks Users to Conserve Gas

A program of self-rationing calling for a saving in natural gas of 15 per cent under normal requirements was announced today by Neil McCarron, local manager of The Ohio Fuel Gas Company for all domestic and commercial customers. Need for the program arose from the greatly increased demands for gas since the start of the war and the gas industry's inability to secure steel for the extension of pipelines to reach new sources of gas supply, the statement said.

The message points out that the savings which will be asked of gas customers from now through the winter are no more severe than the approved program for other fuels.

The Gas Company's program is part of a nation-wide plan to conserve on the use of coal, oil, electricity, water, transportation and communications so that the all military needs can be met without seriously disrupting the needs of civilian life in any locality. Leaders of these industries met with War Production Board officials in Washington some weeks ago and agreed upon their separate plans as a part of the whole.

Since that time The Ohio Fuel Gas Company has been adjusting its operations to the schedule which is necessary. The Company points out the numerous steps it has taken to provide good service

to its customers and offsetting conditions which have arisen to wipe out this program. Also, it states that since the start of the European war when American industry was converting to military production, its industrial demands for gas has increased 47 per cent, domestic and commercial demands 22 per cent, wholesale to unaffiliated companies 54 per cent. The over all consumption of gas for Ohio Fuel has increased 37 per cent since that time.

In recent weeks steel has been allocated for a new pipeline to Texas and the War Production Board expects this line to be in service by the Fall of 1944. Ohio Fuel is promising large amounts of gas from this line, but it will not help this year. Meanwhile, the available gas in the Appalachian area will be used as a pool from which different companies will draw according to the essential needs of their war industries.

Every step is being taken by war industries to hold their fuel requirements to a minimum. Some few of the plants have stand-by fuel which can be used in emergencies, but in most cases these supplies would not last more than a few days.

Even with self-rationing saving 15 per cent of the gas the company predicts that it will be necessary to ask for more drastic curtailments for temporary periods during extreme weather this winter. On one such occasion last winter, the company was high in its praise of the immediate response which gas customers made—saving enough gas to keep war industries producing through the crisis.

The Company has prepared a folder which is available to gas users showing the savings which might be made in the uses of gas in homes and places of business. Perhaps the most drastic of the

suggested savings is the maintenance of heating temperatures at 63 degrees during the day and 55 degrees at night. It is pointed out that this is the same program adopted for other fuels.

It is believed that the patriotic desires of its customers to keep war plants producing are strong enough to cause each user to save his share of gas. Since war plants must continue to use gas, more stringent methods of curtailment would be necessary if the self-rationing program did not succeed.

Notice To Eliminate Smaller Institutional and Industrial Users of Ration Banking

Elimination of Ration Bank Accounts of Smaller Industrial and Institutional Users of Food Through Issuance of New Food Ration Coupons Instead of Certificates.

Use of New Food Ration Coupons

In response to a great many requests from banks, arrangements have now been completed to eliminate smaller institutional and industrial users from Ration Banking. Beginning with the next allotment period, Local Boards will issue food ration coupons to the smaller users and certificates to the larger users on the following basis:

Institutional Users (this includes restaurants, hotels, hospitals, penal institutions, etc.) who did not serve 3,000 or more persons (a person served more than once is counted as many times as he is served) in December 1942, or in any month from March 1943 on, will receive food ration coupons in denominations listed in Section 3 for processed foods and meats and fats. (January and February are omitted from consideration because of the nature of institutional registration with Local Boards.)

Institutional and industrial users above the cut-off line will continue to receive certificates

even if they do not have ration bank accounts.

All institutional and industrial users of sugar will receive certificates every two months which they may bank or not, at their option.

Closing of Certain Accounts
Institutional and industrial users below the cut-off line must notify the bank of that fact and must close out their accounts by drawing their balances down to zero on or before November 1, 1943.

It will not be necessary for either the bank or the depositor to obtain prior approval of the closing of such accounts, as provided in the Ration Banking Manual, but notice by the bank should be sent to the District Office of the OPA when such accounts are closed.

65 PERCENT OF SOLDIERS INSURED

The National Service Life Insurance program in the army has grown to a \$5 billion dollar enterprise, providing insurance protection to 65 percent of all members of the army, according to the War Department. The program was established three years ago.

HUNTERS CAN HELP

Ohio hunters can aid the war effort this year through the transfer of feathers from wild ducks and geese, salvaging furs from wild animals, hides from deer, aiding in locating scrap metals and particularly in salvaging metal from cartridges and shells.

DAIRY PAYMENT RATES

Rates of payment which will be made to farmers delivering whole milk and butterfat to off-set increases in dairy feed costs are announced by WFA. The rates range from 30 to 50 cents a hundredweight and whole milk deliveries and 4 to 6 cents a pound on butterfat. They are applicable for October, November and December, 1943.

DRAFT DELINQUENTS TO BE INDUCTED

Beginning November 1, all men 18 to 38 years of age who are subject to Selective Service but who are delinquent will be put into the 1-A immediate induction class and reported for induction, the Selective Service Bureau of the War Manpower Commission has stated.

USE BOOK FOUR NOVEMBER 1

Housewives will start using green stamps A, B and C from new War Ration Book Four, November 1. These stamps will be valid through December 20 and will be used for buying processed foods in the same way as the blue stamps in book one. The last blue stamps in book two (X, Y and Z) remain good through November 20. Book four is being distributed the latter part of October at the exact time and place being announced locally. One individual may apply for book four for all members of his family residing at the same address. The applicant must have a war ration card three with him for each person for whom he wishes to obtain a book four.

RATION TOKENS IN FEBRUARY

Ration tokens are expected to be ready for use by February. They will be red and blue; each will have a value of one cent. They will be used by consumers as change for processed foods and meat fats ration stamps. The blue tokens with the red stamps for buying foods rationed under the rationing program. The ration coins, made of layers of vulcanized fibre, will be slightly larger than a nickel and smaller than a quarter.

ARMY CUTS BUTTER ALLOWANCE

Teutonic Tactlessness

The Germans have always led the world in "tactlessness." When they took Paris at the end of the Franco-German war they insisted upon staging a triumphal procession through the streets of that half-starved and bitterly humiliated city. This crowning bit of stupidity so wounded French pride that hatred—already intense—deepened into one of passionate fanaticism which has ever since been almost part of Frenchmen's religion.

The Japanese ascend into the "higher strata of psychological imbecility" when they perform such acts as the execution of the American fliers who bombed Tokyo, and now the reported beheading of another Allied flier, and the operation—without an optate—upon an American soldier. But the Japanese figure they cannot be defeated and therefore cannot be punished for their crimes. By this time, however, it must have seeped through the adamantine craniums of Mr. Hitler's Teutonic fraternity that their military position is not so rosy as the Japs think theirs is.

Under like circumstances normal self-loving human beings would begin to take stock of the days when they might be the "invaders" and would "soft pedal" upon atrocities and upon such revenge craving acts as sabotage and looting. Not so the Germans however—if the reports coming from behind their lines are to be credited, for added to atrocities, which are said to be

continuing, are new stories of sabotage and of looting.

There is the rumor current that the buildings and ruins of Ancient and Renaissance Rome are mined and will be destroyed unless our armies by-pass the Holy City. Whether or not this is true remains to be seen, but even this condensation of tactlessness would appear to be within the realm of Nazi stupidity. We are also told that the Germans are looting the museums and palaces of Rome. One would expect this from a conquering horde—but from a retreating army whose own bullwark may become a harvest ground for a bit of "return looting," this procedure, if true, hardly appears to exemplify the pinpoints of tactical prudence. And now to cap the climax of their genius for embittering already bitter enemies, they plant a bomb in the post office in Naples and destroy innocent members of a people who may be represented on their own "trial jury."

Horrible things happen in warfare and the Germans are not the sole offenders; but that race seems to be more capable of getting itself embittered and of lacking understanding of the feelings of non-Teutons—than any people on earth. Not this war only, nor the last World War, but all through the history of Germanic warfare this trait seems to stand out more prominently in this race than in any other.

It's too bad—for them.

ORDINANCE NO. 93
AN ORDINANCE REGULATING MINORS UNDER SIXTEEN YEARS OF AGE ON PUBLIC STREETS AT NIGHT, PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF PLYMOUTH, STATE OF OHIO: Section 1. It shall be unlawful for any minor under the age of sixteen years to be or remain upon the public streets, alleys, commons, public highways or railroad grounds, or to be loitering about depots, public halls and buildings or other places in said Village after the hour of 9:30 o'clock p. m. and before the hour of 5:00 o'clock a. m. in the morning of any day, unless accompanied by some person of mature years as hereinafter provided, or for any parent, guardian or person having the custody and control of such child to allow such child to be upon said streets, alleys, commons, or public highways, and on public buildings or public places in said village between the hours hereinbefore specified, unless accompanied by some person of mature years, and said person being such parent, guardian or person having the legal custody of said child, or some person duly authorized by such parent or guardian to have custody and care of such child.

Section 2. The provisions of section one of this ordinance shall not apply to minors engaged in lawful employment requiring them to be upon the streets, alleys, commons, public highways or public places during the hours hereinbefore specified, unless accompanied by some person of mature years, and said person being such parent, guardian or person having the legal custody of said child, or some person duly authorized by such parent or guardian to have custody and care of such child.

Section 3. It shall be the duty of the Village Mayor to cause some signal to be given, either by whistle, bell or siren each evening as follows: Fifteen minutes before and at the time specified in Section One hereof, between 9:30 o'clock p. m. and after which it shall be unlawful for any minor under the age hereinbefore set forth to be and remain on said streets, alleys, commons, public highways, or on about public places or public buildings, unless said minor comes under an exception as hereinbefore set out.

Section 4. Upon the violation of this ordinance the parent or legal custodian of the child shall be fined in a sum not exceeding \$40.00 and costs of said action, and said minor shall be fined in any sum not exceeding \$40.00 and costs of said action.

Section 5. If any section, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional, illegal or void, such decision shall not effect the validity of the remaining portions of this ordinance.

Section 6. That this ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health and safety and shall go into immediate effect. The reason for such necessity is that this ordinance is needed for the health and safety of the youth of said village.

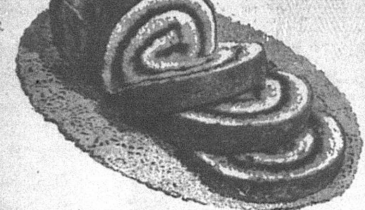
