It would be tragic if voters fail to support the three village levies submitted for renewal on Tuesday's ballot.

The first one is for the general fund, in the amount of two mills, to run for five years, through 1976 tax year.

It will produce about \$8,800 a year. Anybody who has paid any attention at all to the doing of the council since Jan. 1 knows that fiscal manipulations of the highest order have been required to keep the village solvent. Take away the two mill levy and we might as well close the village hall.

The second is for Mary Fate park, in the amount of one-half mill, the maximum allowed by law. It also would run for five years. It would produce about \$2,200 a year. Deprive the park trustees of these funds and we might as well close Mary Fate park. The pity is that scores of right-thinking people will support the levy but don't do a single thing to encourage its use by those who foot the bill!

The third is for Plymouth Fire department, in the amount of one-half mill. Its proceeds will be held in reserve and applied to the purchase of new apparatus. This is a sensible way to husband enough funds so that when we must replace the second apparatus, there will be enough money to do so.

There are those who believe that the state bondsmen equivalent to 18 mills -- some \$220,000 -- obviates the need to renew the two levies which expire, totalling 13.1 mills.

They believe wrongly.

The program in the schools as it stands is not the best in Ohio, not by a long shot. But it has improved, mostly because there was money to do it.

The school board is wisely making no threats. But it doesn't take much wisdom to see that if \$166,000 is removed from the revenues of the system, some 83 per cent of the school operating dollar goes to pay salaries of certificated and non-certificated personnel, the only cut that can be made is in teachers and staff. By our computation, this amounts to about 17 persons.

And since the board is bound by contract to some teachers, it would be compelled to release those, no matter how good they are, to whom it is not bound.

This district simply cannot afford such an eventuality.

Village, school levies head balloting here Tuesday

Three municipal issues and a school operating levy renewal appear on Tuesday's general election ballot when Ohioans go to the polls to choose a president and vice-president, a Congressman and a number of county officials.

Polls will be open from 6:30 a. m. to 6:30 p. m. Polling places here are in First United Presbyterian church for Richland counties and in McCormick's Real Estate office for Huron counties.

The municipal issues are all renewals, a two mill levy to run for five years for the village general fund, a one-half mill levy for the same period for Mary Fate park and a one-half mill levy to run five years for the fire department apparatus fund.

Mayor Elizabeth G. Paddock said yesterday "There ought to be no question in anybody's mind that we need the approval of these levies to continue satisfactory services. The council by resolution has urged the electors of Plymouth to vote for the levies."

The two-mill levy will produce about \$8,800 a year, the others about \$2,200 each. The council also supports renewal of the school district voting levies, amounting together to 13.1 mills and submitted together, although one expiring levy is for four mills and the other for 9.1.

If approved, the levy would produce \$160,448.80 a year.

Plymouth Community club voted unanimously Sept. 24 meeting to support school renewal levy and to urge a "no" vote on the state income tax repeal issue. It also en-

Schools back income tax

Opposition to Issue No. 2, the state income tax repeal, was unanimously approved by Plymouth Board of Education in special session Oct. 25.

A resolution introduced by Member Richard D. Fackler calls on electors of the school district to vote "No" on Issue No. 2 because to do otherwise would disturb present school financing.

Steps to prepare specifications and advertise for bids for a new 66-passenger bus were approved, although the state department of education says it does not yet have enough money to fund the state's share of such purchases.

A lot of names are going to show up when you pull the curtain in your elections booth on Nov. 7. Aside from the national races and the issues, most of the names you will see are people running for county office. Some of them are new, but for the most part, they're the same names confronting the voter election year after election year.

This year one Huron County name is more important than most of the others.

THAT NAME is William Owens.

He is the Democratic candidate for Huron County Prosecutor and the man trying to rock a 16-year family dynasty out of one of the key positions in county government.

His argument is a good one.

Number one on the list is that the current prosecutor, Bernard Freeman, the man charged with arguing the TAXPAYER'S case before the bench is seldom seen in the courtroom. On the other hand, almost all of the courtroom activity is handled by Freeman's nephew.

OWENS argues the prosecutor's place is indeed in the court, working for the people who elected him. And he is.

And that is an argument hardly anyone can disagree with.

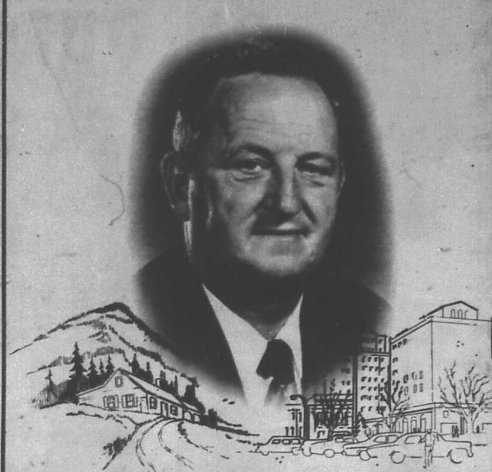

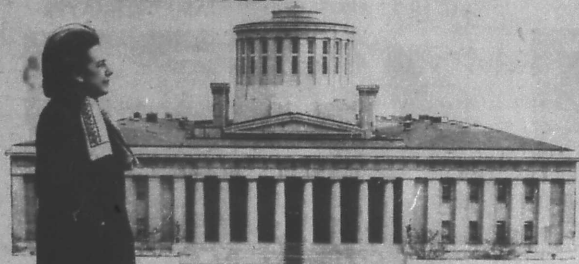

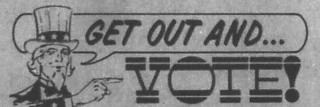
