Byrd became the AL's second seven-game winner, pitching the Kansas City Royals past the Cleveland Indians 6-2 Friday night for Tony Pena's first victory as manager.

Pena, who was named Royals manager Wednesday, won at the ballpark where he had one of his greatest moments as a player — a game-winning homer in the 13th inning of Game 1 of the 1995 AL division series against Boston.

Byrd (7-2) allowed five hits in eight innings and beat the Indians for the second time in six days to join Chicago's Mark Buehrle for the league lead in wins. He threw a season-high 125 pitches.

Byrd threw a first-pitch strike to 24 of 32 batters, and wasn't hurt by a season-high four walks.

Joe Randa and Chuck Knoblauch homered off Chuck Finley (2-5), and Mike Sweeney connected against David Riske in The Indians showed some of he charged in, allowing Ricky
